Improvements to 4th Street between Choctaw and Seneca are currently in design. Field Check plans (roughly 50% complete) were submitted to KDOT and the City for review. On Thursday, June 16th, the design consultant (BHC) and City staff conducted a detailed project walkthrough to help identify any additional items that should be addressed.

The project is still on schedule to bid in March of 2023.

This evening, BHC will be providing an update to the City Commission along with discussing streetscape design options.

DISCUSSION:

During the Commission goal-setting process, the topic of updating the Sign Recognition Policy and consolidating the existing recognition signs was discussed. The current Sign Recognition Policy, adopted in January 2017, provides means for recognizing local community members who have achieved notable accomplishments in their lifetime through the placement of a sign. This policy provides general criteria for community member recognition, location for the signs, and procedure for requesting placement of a sign. The designated location for placement of signs as directed by the policy is the east side of 4th Street, south of the Veterans Administration Hospital (VA) entrance.

Currently, there are a total of eight recognition signs. Two signs, recognizing Murry Dickson and Melissa Etheridge, are placed on the east side of 4th Street, south of the VA entrance. Four signs, recognizing Dr. John Leavitt, Wayne Simien, Jr., Amy Hastings, and Randy Sparks, are placed on the east side of 4th Street, north of the VA entrance. Two additional signs, recognizing Dr. John Leavitt and Wayne Simien, Jr., are placed on the west side of 4th Street, adjacent to Lawson Early Education Center.

The goal of updating the Sign Recognition Policy is to create a consistent, accessible, and aesthetically pleasing way of recognizing notable community members. An update to the policy will include a specified area in Ray Miller Park for locating recognition signs and a means for consolidating and relocating the existing signs to the designated location, as well as more detailed nomination criteria and specifications for the type of signage to be displayed.

Upon direction by the City Commission, staff will prepare options for an update to the Sign Recognition Policy to be presented for discussion at a future date.



SIGN RECOGNITION POLICY Adopted January 10, 2017

The City of Leavenworth is committed to recognizing local community members who achieve great levels of success within their lifetime. The City of Leavenworth has established the following policy to evaluate the placement of signage on major thoroughfares within the City. All signage must be approved by the City Commission and the honoree's accomplishments should meet the following criteria:

- 1. The honoree should have either been born raised or have had a longtime presence within the Leavenworth community. Priority will be given to persons who have achieved success on the state or national level and made contributions to the local Leavenworth community throughout their lifetime. To be recognized, worthy individuals can achieve success in various fields; achievements in the civic, academic, artistic/entertainment, athletic or military background are all considered applicable. Other applicable service or distinctions may be approved by the City Commission on a case-by-case basis. Additional signage considered appropriate is the recognition of our Sister/Brother City relationship and Medal of Honor recipients.
- The location for recognition signage within the City of Leavenworth shall be on the east side of 4th Street South of the V.A. entrance.
- 3. No specific time frame will be placed on the length of time that a sign is erected. If a time comes when the signage needs to be removed because of damage, excessive use of signage or improper placement, the current City Commission can elect to do so without the need for justification.
- 4. Signs will be commissioned by the City of Leavenworth and created at the City's expense if created in-house, otherwise at applicant's expense.
- 5. To request the placement of a recognition sign in the City of Leavenworth, the requesting individual or representative of the honoree should formally submit their request in writing to the City Commission and City Manager and submit the request to the Office of the City Clerk. Requests shall provide background and justification as to why a recognition sign is warranted.



ISSUE:
