## Issue

At the July 11 City Commission meeting, the Commission reviewed, among other items, the 2024 budget request from Leavenworth Main Street (LMS).

In 2023, the City Commission allocated \$39,250 for LMS. For 2024, LMS has requested a 43% increase in City funding to a total of \$56,000.

At the July 11 meeting, the Commission requested further information from LMS regarding the proposed use of the increase in requested funds. That information is attached to this policy report.

## Action

The Commission will be asked to provide consensus on the 2024 funding amount for LMS for inclusion in the City's 2024 Operating Budget.

Options could include:

- 1) Maintaining 2023 funding levels of \$39,250
- 2) Select an increase at a lower level approx. 15 percent increase for example to a level of \$45,000.
- 3) Provide the full funding as requested

Per your request, the Leavenworth Main Street Program is submitting additional information pertaining to the 2024 Budget Proposal request that was previously submitted.

Our 2024 request is in the amount of \$56,000.00, an additional \$16,750 from the 2023 annual investment by the City.

The following is a breakdown of the additional monies requested:

- \$10,000.00 to enhance our marketing/promotion efforts:
  - Highlight Leavenworth as a "Destination City" to the greater KC Metro and surrounding areas.
    - This will look similar to the recent Fox 4 News Commercial Project that we completed, as well as the Great Day KC morning show that our staff appeared on to promote Leavenworth.
    - Develop a campaign during the holiday season to promote shopping in Leavenworth.
  - Continue to enhance our social media presence, to include:
    - Sharing information from local businesses/community partners about what is happening in our City and specials/promotions that are being offered.
    - Boosting social media posts on events, etc. that are scheduled to encourage attendance – this has been effective in reaching a broader audience to shop/eat/play local.
    - Produce informational videos to provide education to the community about Main Street's mission/vision and to also promote events and promotions.
    - Increase staffing hours to allow for the extra time needed to manage these social media enhancements.
  - Further increase all digital advertising efforts.

- \$4,750.00 to increase downtown events offered for families/children throughout the year.
  - Currently: DIY for Dad (Father's Day Weekend), Safe Trick or Treat, Reindeer Romp – free events
  - Goal: Addition of 2 events specific to families/children.
- \$2,000.00 Enhancements to the promotional opportunities that bring patrons into local businesses.
  - Currently: Sidewalk Sales/Christmas in July, Rockin' Around the Christmas Tree (\$88,000 revenue in 2022).
  - 2023 Addition of "Main Street Shenanigans" during March resulted in \$37,000 in downtown shopping revenue.
  - Potentially add an additional promotion during the calendar year.

Our goal for these additional/enhanced efforts is to see results of additional revenues / sales tax for the City, increase awareness of our community and the work of Main Street, and to offer fun activities for families/children.
