City Manager Paul Kramer gave an overview of the leaf removal program and explained weather delays causing this years operations to be problematic. He stated that the crews were currently

working in Grid 9 and then would move to Grid 10. It is taking three to four times the effort per hour due to ice buildup on the leaves.

The Governing Body signed the consent for the special meeting and proper notice was given.

Others present: City Manager Paul Kramer, Public Works Director Mike McDonald, HR Director Lona Lanter, Deputy Public Works Director Mike Hooper, Public Information Officer Melissa Bower, and Deputy City Clerk Cary Collins.

Mayor Preisinger called for a motion to open a Special Meeting.

Commissioner Bauder moved to open a Special Meeting. Commissioner Griswold seconded the motion and was unanimously approved. The Mayor declared the motion carried 4-0 and the meeting opened.

Second Consideration Ordinance No. 8093 Adopting Appendix F Schedule of Fees – City Manager Paul Kramer gave an overview of the fee structure and explained that every license has different requirements; therefore, there are different license fees required for different licenses. Mr. Kramer stated there have been no changes since placed on first consideration at the December 11, 2018 meeting.

Mayor Preisinger called the roll and Ordinance No. 8093 was unanimously approved 4-0.

Consider Renewal of 2019 City Commercial Insurance Package – City Manager Paul Kramer introduced Mike Reilly from Reilly and Sons to discuss the rate increase from \$383,693 in 2018 to \$425,145 in 2019.

Mr. Reilly explained that as you add vehicles throughout the year there is no charge until you renew.

City Manager Kramer stated that the value of the equipment and vehicles added to the policy in 2018 exceeded the current value of the equipment and vehicles that they replaced.

Mr. Reilly handed out a sheet titled "City of Leavenworth Summary of Losses 2013-2018". Mr. Reilly gave an overview of the tables listed on the sheet:

- 3 year rate guarantee had some benchmarks
- Exposures cannot specifically change
- Cap of a loss ratio of 70%
- Large reserve placed on one claim; that kicked us out of rate guarantee program for 2019

Reviewed insurance renewal rate history, estimation of reserves, and summary of where we are at.

Commissioner Bauder asked if they could spread increase over three years and Reilly said they post it to the year.

Commissioner Bauder moved to approve the 2019 renewal of the OneBeacon commercial insurance package in the amount of \$425,145. Commissioner Wilson seconded the motion and was unanimously approved. The Mayor then declared the motion carried 4-0.

Consider Approval of 2019 Pavement Management Design Contract – Public Works Director Mike McDonald presented for consideration a design contract with Affinis Corporation for the 2019 Pavement Management Program in the amount of \$84,730.

Mr. McDonald introduced Kristin Leathers from Affinis and Mr. McDonald gave an overview of the 2019 Pavement Management Program.

Commissioner Griswold moved to approve the design services contract with Affinis Corporation in an amount not to exceed \$84,730 for the 2019 Pavement Management Program. Commissioner Wilson seconded the motion and was unanimously approved. The Mayor then declared the motion carried 4-0.

First Consideration Ordinance Special Use Permit at 2400 S 15th for Solar Panels – City Manager Paul Kramer presented for first consideration a request from Teddy Matlock for a Special Use Permit to allow a solar energy collection system with over 500 square feet of collection surface at his home located at 2400 S 15th St. On December 3, 2018 the Planning Commission held a Public Hearing and unanimously recommended approval.

There was a consensus by the City Commission to place on First Consideration.

The open meeting to resume in the City Commission Chambers at 8:15 p.m. by the clock in the City Commission Chambers. Commissioner Bauder seconded the motion and was unanimously approved. The Mayor declared the motion carried 4-0.

Commissioners Bauder, Wilson, and Griswold returned to the open session at 8:14 p.m. Commissioner Bauder moved to extend the executive session until 8:24 p.m., Commissioner Wilson seconded and the motion carried 3-0.

BACKGROUND:

At the December 18, 2018 City Commission special meeting the City Commission reviewed and placed on first consideration;

AN ORDINANCE ALLOWING A SPECIAL USE FOR A SOLAR COLLECTION SYSTEM TO BE LOCATED AT 2400 S 15TH IN THE CITY OF LEAVENWORTH, KANSAS.

ACTION:

ORDINANCE NO. 8094

AN ORDINANCE ALLOWING A SPECIAL USE FOR A SOLAR COLLECTION SYSTEM TO BE LOCATED AT 2400 S. 15TH STREET IN THE CITY OF LEAVENWORTH, KANSAS.

WHEREAS, under the 2016 Development Regulations of the City of Leavenworth, Kansas, the Governing Body of the City of Leavenworth is given the power to locate special uses in each zoning district by ordinance within said City; and

WHEREAS, the City Planning Commission, after fully complying with the requirements of the Ordinances of the City of Leavenworth, Kansas, held a public hearing on the 3rd day of December, 2018 in the Commission Room, 1st Floor of City Hall, 100 N. 5th Street, Leavenworth, Kansas, the official date and time set as was published in the Leavenworth Times newspaper and mailed to all property owners within 200 feet of the said property on the 9th day of November 2018; and

WHEREAS, upon a motion made, duly seconded, and passed, the City Planning Commission adopted findings of fact and recommended approval of the request for a Solar Collection System at 2400 S 15th Street, Leavenworth, Kansas.

WHEREAS, upon a roll call vote duly passed, the Governing Body adopted the findings of fact and conclusions to allow special use for a Solar Collection System for the property described herein.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEAVENWORTH, KANSAS:

Section 1. That a special use permit be issued for a Solar Collection System on the following described property:

Lot 6 and 11 Block 2 SUNNY SLOPE SUBDIVISION being a replat of Blocks 4, 8, 9 and 16 and East half of Block 15 on Cleveland Park Subdivision City of Leavenworth Leavenworth County Kansas. More commonly referred to as 2400 S 15th St Leavenworth Kansas.

Section 2. That this special use permit is subject to the following:

a) Comply with all applicable building and electrical codes contained in the city's adopted building code. The solar Collection system shall be maintained and in productive use or removed within 90 days of notice from the city that the system is not incompliance with city regulations

Section 3: That this Ordinance shall take effect and be in force from and after its passage by the Governing Body, and its publication once in the official City newspaper.

ISSUE:

Consider approval of bids for the purchase of chemicals used in the operation and maintenance of the Wastewater Treatment Plant.

BACKGROUND:

These chemicals are used for a variety of processes in the treatment of wastewater. A summary of the uses are shown below.

- Hydrogen Peroxide is injected into the raw sludge line before the belt press to control the release of hydrogen sulfide gas in the press room.
- Sodium Hypochlorite and Sodium Hydroxide are used in the wet air scrubber to control odors from the dewatering operation.
- Ferrous Chloride is added to the influent to control odors from the plant processes.
- Polymer is a coagulating agent used in the sludge dewatering process.

STAFF RECOMMENDATION:

Staff recommends approval by the City Commission of the low bids that meet the specifications for the following chemicals as shown not to exceed \$55,000.

ISSUE:

Consider approval for the purchase of a second Tandem Axle dump truck with 201 stainless steel dump body and hydraulics for snow plow. This project was approved as a 2019 Capital Improvements Project. Freightliner is a member of the National Joint Powers Alliance (NJPA) – now Sourcewell.

BACKGROUND:

The City of Leavenworth currently owns two 2005 Sterling Tandem Axle dump trucks with snowplows for the WPC to use to haul sludge and augment streets in severe snow. The first replacement dump truck approved by the City Commission in 2018 should be delivered in the spring of 2019. This purchase is to replace the second 2005 Sterling dump truck. These trucks have over 200,000 miles. The dump trucks haul dewatered sludge to the landfill four times a week each. A round trip takes two hours and 15 minutes and a total of 59 miles. Repair costs in 2017 were \$6,241.67 for truck 3364 and \$16,375.97 for truck 3366.

Bids received:

WPC discussed the equipment they offered and the equipment needed to build this truck with Freightliner. The truck will come with a Henderson 201 Stainless steel bed and existing plow will be reused. Both dealers are in Kansas City.

Establishes and provides nationally-leveraged and competitively-solicited purchasing contracts under the guidance of uniform Municipal Contracts Law (M.S. 471.345 subdivision 15).

Contracts are awarded at the manufacturer level and sales are made through local dealerships by receiving national volume pricing

STAFF RECOMMENDATION:

The Staff recommends the City Commission approve the low bid from Kansas City Freightliner Sales for the 2020 Freightliner 108SD Dump Truck at a cost of \$125,390 through Sourcewell.

OPTIONS/ALTERNATIVES: The City Commission can accept the low bid as recommended by City Staff, or can ask the staff to re-bid.
