CALL TO ORDER - The Governing Body met in regular session and the following commission members were present: Mayor Mark Preisinger, Mayor Pro-Tem Jermaine Wilson, Commissioners Nancy Bauder and Larry Dedeke, Commissioner Myron J. (Mike) Griswold was present via phone.

Others present: City Manager Paul Kramer, Assistant City Manager Taylour Tedder, Police Chief Pat Kitchens, Public Works Director Mike McDonald, Deputy Public Works Director Mike Hooper, Chief Building Inspector Hal Burdette, Convention and Tourism Director Kristi Lee, WPC Superintendent Chuck Staples, Parks and Recreation Director Steve Grant, Parks Superintendent Brian Bailey, Finance Director Ruby Maline, Public Information Officer Melissa Bower, City Attorney David E. Waters and City Clerk Carla K. Williamson.

Mayor Mark Preisinger opened the meeting with the pledge of allegiance followed by silent meditation.

OLD BUSINESS:

Consideration of Previous Meeting Minutes:

Commissioner Bauder moved to approve the minutes from the July 24, 2018 regular meeting and the August 7, 2018 special meeting as presented. Commissioner Dedeke seconded the motion and was unanimously approved. The Mayor declared the motion carried 5-0.

Second Consideration Ordinances:

Second Consideration Ordinance No. 8082 Demolition Assessments – City Clerk Carla Williamson stated that there have been no changes to the ordinance since it was first introduced on July 24, 2018. Ordinance No. 8082 was presented for second consideration and a roll call vote.

Mayor Preisinger called the roll and Ordinance No. 8082 was unanimously approved 5-0.

Second Consideration Ordinance No. 8083 Nuisance Assessments - City Clerk Carla Williamson stated that since the first consideration, two property owners paid the fees and those properties were removed. There have been no other changes to the ordinance since it was first introduced on July 24, 2018. Ordinance No. 8083 was presented for second consideration and a roll call vote.

Mayor Preisinger called the roll and Ordinance No. 8083 was unanimously approved 5-0.

General Items:

Mosquito Program Discussion – City Manager Paul Kramer introduced Kansas State University Entomologist Jeff Whitworth (PhD) and Holly Davis (PhD) to speak to the Commission about the City's mosquito program and mosquito control in general.

Dr. Whitworth and Dr. Davis discussion items:

- They visit many cities throughout the state regarding mosquito programs and entomology in general
- Often hear people say that they look on the internet and Google information on mosquito programs; Don't do that unless it is a .gov or .edu website to get accurate information
- Need to know what species of mosquitos are in the area
- Larvicides and Adulticides (foggers) are the two most popular options
- Public information program educating the public about preventative measures (removal of standing water)
- Larvicides do not affect non-target organisms
- Adult mosquito targeted programs (adulticide chemicals such as permethrin), fogging down the road does not cause unintended killing of pollinators
- Fog is in the air for a while but does not last
- Fogging chemicals are safe for humans
- Must be on the mosquito when fogging but does not last-will kill some adult mosquitos
- In evening pollinators are not in the area and does not affect them
- Mosquitos are 100 times more sensitive than bees and other pollinators to fogging chemicals
- Pollinators are only present when there are flowers
- Studies have been conducted and the bee population in Kansas is not declining
- A scientific review of the City program by Dr. Whitworth and Dr. Davis finds that there is no problem with the program or chemicals being used however, it effects the adult population only for a short period of time
- The chemical that the City uses is permethrin. If used in large doses will kill pollinators but the dose that the city uses will not hurt them unless the pollinator flies directly into the fog at the time of spraying
- Permethrin is safe for humans
- There are no official statistics on the number of cities in the state that have mosquito programs

Mayor Preisinger asked about plants and does the chemical used affect plants such as milkweed which butterflies feed on. Dr. Whitworth said it does not affect plants or the insects that land on them. Mayor Preisinger also asked how effective programs are for keeping the number of mosquito borne illnesses at bay. Dr. Whitworth stated that Zika virus is not in Kansas yet, encephalitis is not a big problem in Kansas and West Nile virus cases have been reported in Kansas. He himself did contract West Nile virus. The best defense against mosquito borne illnesses is for a person to wear insect repellants that contain Deet.

Public Works Director Mike McDonald:

The City uses larvicides in areas that are known to have standing water such as creeks that don't flow regularly and that are on city property that we have access to. City uses a donut shaped product that this thrown into the water. Wind speeds are checked prior to fogging. If wind speed is

too high that day, they do not fog. Mr. McDonald estimated the cost of the fogging chemical at \$500.00 per barrel and that the city uses 4-6 barrels per year.

Commissioner Griswold asked about the cost. City Manager Kramer will put together information regarding the cost of the chemical and will take into consideration staff time and equipment used and this will be reviewed at a future Study Session.

Commissioner Dedeke stated that he was in favor of continuing with a cost of about \$8000 per year and feels that it is doing some good.

Public Hearings:

2019 Budget Hearing

Open Public Hearing - Commissioner Dedeke moved to open the public hearing for the 2019 Budget. Commissioner Bauder seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

City Manager Kramer stated that there have been no changes since the budget meetings. The budget has no mill increase and there have been no citizen comments.

Public Comments: none

Close Public Hearing - Commissioner Dedeke moved to close the public hearing for the 2019 Budget. Commissioner Bauder seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

Adopt 2019 Budget – Commissioner Bauder moved to approve the 2019 Budget, as presented. Commissioner Dedeke seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

Adopt Resolution No. B-2204 Housing Budget - Commissioner Dedeke moved to approve the 2019 Housing Budget, Resolution No. B-2204. Commissioner Bauder seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

2018 Edward Bryne Memorial Justice Assistance Grant – Police Chief Pat Kitchens presented for consideration and approval the 2018 Edward Byrne Memorial Justice Assistance Grant. The grant is typically used to purchase police equipment. The grant application required the City of Leavenworth to share the allocation of the grant with the Leavenworth County Sheriff's Office. If approved by the Commission, the City of Leavenworth will receive \$15,170.00 and the County will receive \$10,000.00. This will require the approval of the City Manager and the City Attorney to sign an Interlocal Agreement with Leavenworth County and for the Mayor to sign an additional document entitled "Certifications and Assurances by the Chief Executive of the Application Government".

Commissioner Bauder moved to authorize the Police Department to apply for the 2018 Edward Byrne Memorial Justice Assistance Grant in the amount of \$25,170.00 of which \$10,000.00 will be given to the Leavenworth County Sheriff's Office as presented. Commissioner Wilson seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

Bids, Contracts and Agreements:

Consider Proposals for the Replacement of Cody Park Playground Equipment –Parks Superintendent Brian Bailey presented for consideration the proposals submitted for the replacement of playground equipment for Cody Park. Members of the Parks and Community Activities Advisory Board were also present. Jim Mathis the Chairman of the Board addressed the Commission and discussed the review process. Proposals were opened on August 1, 2018 and reviewed by Staff. On August 6, 2018 the Parks and Community Activities Advisory Board reviewed and discussed the proposals. The board recommends the proposal submitted by J. Oliver Construction LLC in the amount of \$124,500.00.

Commissioner Bauder moved to approve the proposal from J. Oliver Construction LLC for the purchase and installation of playground equipment in an amount not to exceed \$124,500.00. Commissioner Wilson seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

Consider Bids for Performing Arts Center (PAC) HVAC Upgrade Phase III - Parks and Recreation Director Steve Grant presented for consideration the bids for the Performing Arts Center (PAC) HVAC Upgrade Phase III. Staff recommends approval of the low bid received from PM Contracting Inc. in the amount not to exceed \$46,200.00. Bids were opened on August 3, 2018 and were as follows:

Commissioner Bauder moved to approve the bid from PM Contracting Inc. in the amount not to exceed \$46,200.00 Commissioner Dedeke seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

Consider Sole Source Contract for City Hall HVAC System Upgrade and Repair - Public Works Director Mike McDonald presented for consideration a sole source bid from D'Agostino Mechanical for the 2018 HVAC System Upgrade & Repair Project in the amount not to exceed \$38,285.00 which includes the price of five (5) year parts and warranty.

Commissioner Bauder moved to approve the sole source bid from D'Agostino Mechanical in the amount not to exceed \$38,285.00 including a 5 year warranty. Commissioner Dedeke seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

Consider Bids for Water Pollution Control (WPC) Tandem Axle Dump Truck - Public Works Director Mike McDonald presented for consideration bids for a Tandem Axle Dump Truck. Bids were acquired from International and Freightliner which are both members of the National Joint Powers Alliance (NJPA). Staff recommends approval of the low bid from Kansas City Freightliner Sales for the 2020 Freightliner 108SD Dump Truck in an amount not to exceed \$124,790.00. Bids received were as follows:

Commissioner Wilson moved to approve the bid from Kansas City Freighter Sales for a 2020 Freightliner 108SD Dump Truck in the amount not to exceed \$124,790.00. Commissioner Bauder seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

Consider Contract Website Redesign – Assistant City Manager Taylour Tedder presented for consideration a contract with Municipal Code Corporation (Municode) for website redesign services in the amount of \$36,000.00 for the first year of implementation and training. A request for qualification was released and published on May 23, 2018. Four website vendors submitted proposals which were reviewed by Staff. The vendors included Civic Plus, Civic Live, Vision, and Municode.

Commissioner Bauder moved to approve the service agreement for website design and replacement with Municipal Code Corporation in the amount not to exceed \$36,000.00 for the first year of implementation and training. Commissioner Wilson seconded the motion and was unanimously approved. The Mayor then declared the motion carried 5-0.

First Consideration Ordinances:

First Consideration Charter Ordinance to Repeal and Replace Charter Ordinance No. 55 Related to Transient Guest Tax – City Manager Paul Kramer presented for first consideration a charter ordinance to repeal and replace Charter Ordinance No. 55. The new charter ordinance will include the revision of K.S.A. 12-1696 defining words and phrases and expand upon the authorized use of the transient guest tax.

There was a consensus by the City Commission to place on first consideration.

First Consideration Ordinance Uniform Public Offense Code 2018 – Police Chief Pat Kitchens presented for first consideration an ordinance to adopt by reference the 2018 Uniform Public Offense Code for Kansas Cities.

City Attorney Waters stated that there were a couple areas of the final ordinance in which he and the City Clerk will need to refine and those will come back to the Commission on second consideration.

There was a discussion regarding littering laws and the option of keeping the current city code or adopt the UPOC regulation.

There was a consensus to adopt the UPOC regulation to replace the current code.

There was a consensus by the City Commission to place on first consideration.

First Consideration Ordinance Standard Traffic Ordinance 2018 – Police Chief Pat Kitchens presented for first consideration an ordinance to adopt by reference the 2018 Standard Traffic Ordinance for Kansas Cities.

There was a consensus by the City Commission to place on first consideration.

First Consideration Ordinance Intersection Traffic Control Devices 2018 – Police Chief Pat Kitchens presented for first consideration an ordinance to adopt by reference the 2018 Intersection Traffic Control Device Master Index.

There was a consensus by the City Commission to place on first consideration.

CONSENT AGENDA:

POLICY REPORT SECOND CONSIDERATION CHARTER ORDINANCE NO 60 REPEAL AND REPLACING CHARTER ORDINANCE 55 TRANSIENT GUEST TAX

BACKGROUND:

At the August 14, 2018 City Commission meeting the City Commission reviewed and placed on first consideration;

"A CHARTER ORDINANCE OF THE CITY OF LEAVENWORTH, KANSAS, RELATING TO TRANSIENT GUEST TAX LEVY, EXEMPTING THE CITY FROM THE PROVISIONS OF K.S.A. 12-1696 THROUGH 12-1698a, INCLUSIVE, PROVIDING FOR ADDITIONAL AND SUBSTITUTE PROVISIONS ON THE SAME SUBJECT, AND REPEALING CHARTER ORDINANCE NO. 55."

The passage of a charter ordinance requires the following:

- That the charter ordinance be passed a vote of 2/3 of the governing body rather than a simple majority.
- After passed by the governing body the charter ordinance must be published once each week for two consecutive weeks in the official city newspaper.
- A 60-day waiting period is required after publication to allow time for the public to petition for a referendum on the matter. If no is filed during this time, then the charter ordinance becomes effective on the 61st day.
- A petition is sufficient if 10% of the number of electors who voted in the last regular city election sign. If a sufficient petition is filed during the 60-day period, an election is held and the charter ordinance becomes effective only if a majority of the electors vote in favor of it. An election, if called, must be called within 30 days after the filing of the petition and must be held within 90 days of the filing of the petition. The governing body has the option of deciding not to pursue the matter and the charter ordinance may be allowed to die. When the governing body calls an election voluntarily, or upon petition, the election ordinance is published once each week for three consecutive weeks in the official city newspaper. The county election officer (county clerk or election commissioner) conducts the election the same as any other city election. The city clerk has only the duties he or she normally would have in a city election.
- The City Clerk must send a copy of all charter ordinances to the Secretary of State's office after the 61st day or approval by election.

There have been no changes since this item was placed on first consideration. If approved and there is no petition for a referendum on the matter, the Charter Ordinance will become effective on November 7, 2018.

ACTION:

Charter Ordinance No. 60 is now presented for second consideration and requires a roll call vote approval of 2/3 of the Governing Body to pass.

CHARTER ORDINANCE NO. 60

A CHARTER ORDINANCE OF THE CITY OF LEAVENWORTH, KANSAS, RELATING TO TRANSIENT GUEST TAX LEVY, EXEMPTING THE CITY FROM THE PROVISIONS OF K.S.A. 12-1696 THROUGH 12-1698a, INCLUSIVE, PROVIDING FOR ADDITIONAL AND SUBSTITUTE PROVISIONS ON THE SAME SUBJECT, AND REPEALING CHARTER ORDINANCE NO. 55.

WHEREAS, the City of Leavenworth, Kansas has heretofore adopted Charter Ordinance No. 55 pursuant to the provisions of Section 5(c) of Article 12 of the Constitution of the State of Kansas exempting itself and making inapplicable to it provisions of K.S.A. 12-1697 to 12-1698a and providing substitute provisions on the same subject; and

WHEREAS, Section 5(c)(4) of Article 12 of the Constitution of the State of Kansas provides that a Charter Ordinance may be repealed or amended by charter ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEAVENWORTH, KANSAS:

SECTION 1. That pursuant to the provisions of Section 5(c) of Article Twelve (12) of the Constitution of the State of Kansas, the City of Leavenworth, Kansas, hereby exempts itself from the provisions of K.S.A. 12-1696 through 12-1698a, inclusive, and adopts the following additional and substitute provisions:

- a. As used in this Charter Ordinance, the following words and phrases shall have the meanings respectively ascribed to them herein:
 - i. "<u>Person</u>" means an individual, firm, partnership, corporation, joint venture or other association of persons;
 - ii. "Hotel, motel or tourist court" means any structure or building which contains rooms furnished for the purposes of providing lodging, which may or may not also provide meals, entertainment or various other personal services to transient guests, and which is kept, used, maintained, advertised or held out to the public as a place where sleeping accommodations are sought for pay or compensation by transient or permanent guests and having more than two bedrooms furnished for the accommodation of such guests. For purposes of this Charter Ordinance, the terms shall also mean any lodging establishment (as such term is defined in K.S.A. 36-501, as amended), any hotel, lodging house, boarding house, or resort (as such terms are used in City Code Sec. 54-304 et seq., as amended), and any shortterm rental (including but not limited to so-called AirBNBs, VRBOs, or similar rental arrangements, as may be further defined by the City from time to time). The terms shall not include group homes (as defined by K.S.A. 12-736, as amended).

- iii. "<u>Transient guest</u>" means a person who occupies a room in a hotel, motel or tourist court for not more than 28 consecutive days;
- iv. "<u>Business</u>" means any person engaged in the business of renting, leasing or letting living quarters, sleeping accommodations, rooms or a part thereof in connection with any motel, hotel or tourist court;
- v. "Economic development and tourism promotion" means:
 - 1. Activities to attract visitors into the community through marketing efforts, including advertising, directed to at least one of the five basic convention and tourism market segments consisting of group tours, pleasure travelers, association meetings and conventions, trade shows and corporate meetings and travel;
 - 2. support of those activities and organizations which encourage increased lodging facility occupancy;
 - 3. economic development and related expenditures as may be determined by the governing body, including but not limited to:
 - A. Contracting with one or more agencies, organizations, individuals or groups to promote conventions and tourism for the City, and/or to promote, pursue, and manage the City's economic development activities including securing and retaining business and industry opportunities for the City;
 - B. Operating, maintaining, expanding and developing of City facilities and public areas connected with conventions or tourism;
 - C. Making payments for principal or interest for bonds issued to construct convention, community or civic centers, parks, recreational or other public facilities or public amenities that may be used in connection with conventions or tourism basis as it relates to its use for conventions, tourism and the attraction and retention of business and industry;
 - D. Defraying the cost of providing municipal services to festivals, convention and tourism functions, such as but not limited to Finance, Legal, Police, Fire, Municipal Services and Parks and Recreation Department personnel utilized for festivals, conventions, tourism and the attraction of business and industry;
 - E. Creating innovative projects and activities that relate to the promotion of conventions and tourism;

- F. activities to attract the location or relocation of industrial or commercial enterprises into the community through marketing efforts, including advertising and incentives;
- G. activities designed to encourage retention and expansion of existing industrial or commercial enterprises in the community;
- H. Promoting the general economic welfare of the City, including the attraction and retention of business and industry.
- vi. "<u>Accommodations broker</u>" means any business which maintains an inventory of two or more rooms in one or more locations which are offered for pay to a person or persons for not more than 28 consecutive days.
- b. In order to provide revenues to promote tourism and conventions, the governing body of the City of Leavenworth, Kansas (City) is hereby authorized to levy a transient guest tax at not to exceed the rate of ten percent (10%) upon the gross receipts derived from or paid directly or through an accommodations broker by transient guests for sleeping accommodations, exclusive of charges for incidental services or facilities, in any hotel, motel or tourist court. The percentage of such tax shall be determined by the City governing body and shall be specified in the resolution authorizing the same.
- c. Any transient guest tax levied pursuant to this section shall be based on the gross rental receipts collected by any business or accommodations broker.
- d. The transient guest taxes levied pursuant to this section shall be paid by the consumer or user to the business and it shall be the duty of each and every business to collect from the consumer or user the full amount of any such tax, or an amount equal as nearly as possible or practicable to the average equivalent thereto. Each business collecting any of the taxes levied hereunder shall be responsible for paying over the same to the City, and the City shall administer and enforce the collection of such taxes. To the extent the City timely and actually receives transient guest taxes from a third-party provider or platform (whether pursuant to a voluntary collection agreement or otherwise), then a business shall not be responsible for payment of transient guest taxes; provided, that to the extent transient guest taxes are not so timely or actually received, the business will remain responsible for payment of transient guest taxes.
- e. The collection of any City transient guest tax authorized to be levied pursuant to this section has previously commenced as of July 1, 2015, under previous Charter Ordinance No. 55, and shall continue as of the effective date of this Charter Ordinance.
- f. Any tax levied and collected shall become due and payable by the business monthly, on or before the 25th day of the month immediately succeeding the month

in which it is collected, with the first payment due and payable on or before the 25th day of the month specified in the resolution of the governing body which levies the tax. Each business shall make a true report to the City, on a form prescribed by the City Clerk, providing such information as may be necessary to determine the amounts to which any such tax shall apply for all gross rental receipts for the applicable month or months, which report shall be accompanied by the tax disclosed thereby. Records of gross rental receipts shall be kept separate and apart from the records of other retail sales made by a business in order to facilitate the examination of books and records as provided herein.

- g. The City Clerk or the City's authorized representative shall have the right at all reasonable times during business hours to make such examination and inspection of the books and records of a business as may be necessary to determine the accuracy of such reports.
- h. The City Clerk is hereby authorized to administer and collect any transient guest tax levied pursuant to this Charter Ordinance and to adopt such procedures as may be necessary for the efficient and effective administration and enforcement of the collection thereof. Whenever any business liable to pay any transient guest tax refuses or neglects to pay the same, the amount, including any penalty, shall be collected in the manner prescribed for the collection of the transient guest tax by the Code of Ordinances and amendments thereto. All of the taxes collected under the provisions of this Charter Ordinance shall be remitted by the City to the City Clerk in accordance with the provisions of the Code of Ordinances, and amendments thereto. Upon receipt of each such remittance, the City Clerk shall deposit the entire amount in the City treasury, and the city treasurer shall credit 2% of all taxes so collected to the City general fund to defray the expenses of the department in administration and enforcement of the collection thereof. The remainder of such taxes shall be credited to the city transient guest tax fund (also known as the convention and visitors bureau fund), which fund is hereby established.
- i. All such moneys received by the City Clerk or city treasurer from disbursements from the city transient guest tax fund shall be credited to the tourism and convention promotion fund of the city and shall only be expended for economic development and tourism promotion.
- j. Interest and penalties for failure to pay or untimely payment of transient guest tax shall be as follows:
 - i. If any taxpayer shall fail to pay the tax levied pursuant to this Charter Ordinance, and amendments thereto, there shall be added to the unpaid balance of the tax, interest at the rate per month prescribed by the Code of Ordinances, and amendments thereto, from the date the tax was due until paid.
 - ii. If any taxpayer due to negligence or intentional disregard fails to pay the tax due at the time required by or under the provisions of this Charter

Ordinance, and amendments thereto, there shall be added to the tax a penalty in an amount equal to 10% of the unpaid balance of tax due.

- iii. If any person fails to pay any tax, within sixty (60) days from the date the return or tax was due, except in the case of an extension of time granted by the city manager, there shall be added to the tax due a penalty equal to 25% of the amount of such tax.
- iv. If any taxpayer, with fraudulent intent, fails to pay any tax or make, render or sign any return, or to supply any information, within the time required by or under the provisions of this Charter Ordinance, and amendments thereto, there shall be added to the tax a penalty in an amount equal to 50% of the unpaid balance of tax due.
- v. Penalty or interest applied under the provisions of subsections j.i and j.iv shall be in addition to the penalty added under any other provisions of this section, but the provisions of subsections j.ii and j.iii shall be mutually exclusive of each other.
- vi. The failure of the taxpayer to comply with the provisions of subsections j.ii and j.iii was due to reasonable causes and not willful neglect; the city manager may waive or reduce any of the penalties upon making a record of the reasons therefor.
- vii. For serious or repeated and/or continuous violations of any of the requirements of this Charter Ordinance, or for interference with the City staff performance of duties, any license to operate or conduct business as a hotel, motel, or tourist court may be suspended and/or permanently revoked after an opportunity for a hearing before the City Commission has been provided. Prior to such action, the City Clerk shall notify the license holder in writing, stating the reasons for which the license is subject to suspension and advising that the license shall be temporarily suspended at the end of thirty (30) days following service of such a notice, unless a request for a hearing is filed with the City Clerk, by the license holder, within ten (10) days.
- viii. Hearings provided for in this Charter Ordinance shall be conducted by the City Commission at a time and place designated by the City Commission. Based upon the record of such hearing, the City Commission shall make a finding and shall sustain, modify, or rescind any official notice or order considered in the hearing. A written report of the hearing decision shall be furnished to the license holder by the City Clerk.
- ix. In addition to all other penalties provided by this section, any person who willfully fails to pay any tax imposed under this Charter Ordinance, and amendments thereto, or who makes a false or fraudulent return, or fails to keep any books or records necessary to determine the accuracy of the person's reports, or who willfully violates any regulations of the City, for

the enforcement and administration of the provisions of this Charter Ordinance, inclusive, and amendments thereto, or who aids and abets another in attempting to evade the payment of any tax imposed or who violates any other provision of this Charter Ordinance, inclusive, and amendments thereto, shall, upon conviction thereof, be fined not less than \$100.00 nor more than \$1,000.00, or be imprisoned in the city / county jail not less than one (1) month nor more than six (6) months, or be both so fined and imprisoned, in the discretion of the court.

k. The transient guest tax authorized by this Charter Ordinance (and previous charter ordinances replaced by this Charter Ordinance) shall be levied pursuant to resolution of the City Commission authorizing the same. Current resolution B-2110 establishing rates as to transient guest taxes shall remain in effect, and is unchanged by this Charter Ordinance, and is hereby ratified.

SECTION 2: Charter Ordinance No. 55 is hereby deleted and repealed in its entirety.

SECTION 3: This Charter Ordinance shall be published once a week for two (2) consecutive weeks in the official city newspaper.

SECTION 4. This Charter Ordinance shall take effect sixty-one (61) days after its final publication, unless a sufficient petition for a referendum is filed and a referendum held on this Charter Ordinance as provided in Article 12, Section 5, Subsection (c)(3) of the Constitution of the State of Kansas, in which case this Charter Ordinance shall become effective if approved by a majority of the electors voting thereon.

BACKGROUND:

At the August 14, 2018 City Commission meeting the City Commission reviewed and placed on first consideration;

"AN ORDINANCE AMENDING CHAPTER 70 OF THE CODE OF ORDINANCES REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE LIMITS OF THE CITY OF LEAVENWORTH, KANSAS; INCORPORATING BY REFERENCE THE "UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES" EDITION OF 2018, WITH CERTAIN OMISSIONS AND CHANGES."

The following changes have been made and are recommended by Staff and the City Attorney since the ordinance was introduced on first consideration at the August 14, 2018 City Commission meeting:

- There was a consensus by the Governing Body to eliminate the section of the City code regarding *Littering*. The Uniform Public Offense Code (UPOC) now addressed Criminal Littering in Sec 6.8. That section is now removed from the ordinance before you.
- Sec. 9.9.2 Possession of Drug Paraphernalia and Simulated Controlled Substances
 Statutory reference has been added.
- Sec 10.23 Trafficking in Counterfeit Drugs
 - Section has been removed from the ordinance. The UPOC contains identical language and therefore unnecessary to include as an amendment.
- Sec 10.6 Air Gun, Air Rifle, Bow and Arrow, Slingshot or BB Gun
 - This section remains in the ordinance with language unchanged. It has been moved within the ordinance to keep it in sequential order.

It should be added that in 2019 the City Code of Ordinances will undergo a complete recodification, as approved by the Governing Body in the 2019 budget. At that time, Staff and

the City Attorney will review the existing amendments to determine how they differ from the UPOC and what if any changes may be recommended for consideration by the Commission.

RECOMMENDATION:

Staff recommends approval of Ordinance No. 8084.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEAVENWORTH, KANSAS:

Section 1. That the Code of Ordinances, City of Leavenworth, Kansas, Chapter 70, Offenses, Section 70-1, is hereby deleted in its entirety and amended to read as follows:

Sec. 70-1 Incorporating Uniform Public Offense Code – Incorporated by reference.

Is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Leavenworth, Kansas, that certain code known as the *Uniform Public Offense Code for Kansas Cities*, Edition of 2018 prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereinafter omitted, deleted, notified or changed. One official copy of said *Uniform Public Offense Code* shall be marked or stamped "Official Copy as Adopted by Ordinance No. 8084" with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this Ordinance and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

Section 2. That the Code of Ordinances, City of Leavenworth, Kansas, Chapter 70, Offenses, Section 70-2, is hereby deleted in its entirety and amended to read as follows:

Sec. 70-2 Same-Amendments.

Notwithstanding the foregoing, Section 5.7, Section 9.9.2, and Section 10.6 of said *Uniform Public Offense Code* are hereby deleted in their entirety and amended to read as follows:

5.7 SELLING, GIVING OR FURNISHING CIGARETTES OR TOBACCO PRODUCTS TO A PERSON UNDER 21 YEARS OF AGE.

- (a) It shall be unlawful for any person to:
 - Sell, furnish or distribute to any person under the age of 21 years any cigarettes, electronic cigarettes, or tobacco products; or

- (2) Buy any cigarettes, electronic cigarettes, or tobacco products for any person under 21 years of age.
- (b) It shall be a defense to a prosecution under subsection (a) of this section if:
 - (1) The defendant is a licensed retail dealer, or employee thereof, or a person authorized by law to distribute samples;
 - (2) The defendant sold, furnished or distributed the cigarettes, electronic cigarettes, or tobacco products to the person under 21 years of age with reasonable cause to believe the person was of legal age to purchase or receive cigarettes, electronic cigarettes or tobacco products; and
 - (3) To purchase or receive the cigarettes, electronic cigarettes, or tobacco products, the person under 21 years of age exhibited to the defendant a driver's license, Kansas non driver's identification card or other official or apparently official document containing a photograph of the person and purporting to establish that the person was of legal age to purchase or receive cigarettes, electronic cigarettes, or tobacco products.
- (c) It shall be a defense to a prosecution under subsection (a) of this section if:
 - (1) The defendant engages in the lawful sale, furnishing or distribution of cigarettes, electronic cigarettes, or tobacco products by mail; and
 - (2) The defendant sold, furnished or distributed the cigarettes, electronic cigarettes, or tobacco products to the person by mail only after the person had provided to the defendant an unsworn declaration, conforming to K.S.A. 53-601, that the person was 21 or more years of age.
- (d) For purposes of this section, the person who violates this section shall be the individual directly selling, furnishing or distributing the cigarettes, electronic cigarettes, or tobacco products to any person under 21 years of age, or the retail dealer who has actual knowledge of such selling, furnishing or distributing by such individual or both.
- (e) Notwithstanding any separate definition in Sec. 1.1 of the Uniform Public Offense Code for Kansas Cities, the term electronic cigarette means a device that delivers nicotine or other substances to the person inhaling from the device, including but not limited to any electronic cigarette, cigar, pipe, or hookah, including any component, part, or accessory of such a device, whether or not sold separately. Electronic cigarette shall not include any products that

have been approved by the United States Food and Drug Administration for sale as a tobacco cessation product or for other therapeutic purposes where such product is marketed and sold solely for such an approved purpose.

- (f) As used in this section, *sale* means any transfer of title or possession or both, exchange, barter, distribution or gift of cigarettes or tobacco products, with or without consideration.
- (g) It is unlawful for any person who is a retail dealer to fail to post and maintain in a conspicuous place in the dealer's establishment the following notice: "BY LAW, CIGARETTES AND TOBACCO PRODUCTS MAY BE SOLD ONLY TO PERSONS 21 YEARS OF AGE AND OLDER." Retailer shall mean any person, firm or corporation engaged in the business of selling tobacco products, alternative nicotine products, or vapor products by personal handling to an ultimate customer or consumer.

Violation of this section is a class B violation punishable by a minimum fine of \$200.

9.9.2 DRUG PARAPHERNALIA, SIMULATED DRUGS AND CONTROLLED SUBSTANCES; DISPLAY, SALE, POSSESSION OR DELIVERY PROHIBITED.

- (a) No person shall sell or offer for sale, use or possess with intent to use:
 - (1) Any simulated controlled substance as designated in K.S.A. 21-5701;
 - (2) Any drug paraphernalia, as designated in K.S.A. 21-5701, to use, store, contain, conceal, inject, ingest, inhale or otherwise introduce into the human body a controlled substance in violation of the Uniform Controlled Substances Act, K.S.A. 65-4101 *et seq.*, and any amendments thereto; or
 - (3) Any drug paraphernalia to plant, propagate, cultivate, grow or harvest less than five marijuana plants.
- (b) The fact that an item has not yet been used or did not contain a controlled substance at the time of the seizure is not a defense to a charge that the item was possessed with the intention for use as drug paraphernalia.
- (c) No person shall deliver, possess with intent to deliver, manufacture with intent to deliver or cause to be delivered within this City any drug paraphernalia, knowing, or under circumstances where one reasonably should know, that it will be used to use, store, contain, conceal, inject, ingest, inhale or otherwise introduce into the human body a controlled substance in violation of the Uniform Controlled Substances Act and amendments thereto.
- (d) It shall be unlawful for any person to display for sale any drug paraphernalia

or simulated controlled substance or simulated drug in or upon any premises.

- Nothing in this Section shall be construed to prohibit the selling, dispensing, or giving away of such items by a practitioner or pharmacist to a patient for lawful purposes.
- (e) For the purpose of sentencing the offense is classified as a Class A misdemeanor as set forth in the Uniform Public Offense Code and the sentence shall be a definite term of confinement in the city or county jail which shall be fixed by the Court and shall not exceed one year. In addition to or instead of the confinement authorized by law a fine up to \$2,500.00 may be imposed by the Court.

10.6 AIR GUN, AIR RIFLE, BOW AND ARROW, SLINGSHOT OR BB GUN.

The unlawful operation of an air gun, air rifle, bow and arrow, slingshot or BB gun is the shooting, discharging or operating of any air gun, air rifle, bow and arrow, slingshot or BB gun, within the city, except by permit authorized by the city for deer hunting or within the confines of a building or other structure from which to projectiles cannot escape; provided, that a bow and arrow may be used in an open air archery range meeting the following requirements.

- (1) An open, flat plain with a clear and unobstructed field of distance. The maximum distance between archer and target shall be no more than 40 yards.
- (2) Target shall be situated so that any path, target, road or building is located with a 30 degree arc centered perpendicular with the shooter and target extending a minimum of 40 yards behind the target.
- (3) A target backstop be constructed which is at least 12 feet wide and 8 feet high behind each target. The backstop is to be constructed and maintained using a material, which would capture and trap arrows shot into it. The material used must not cause arrows to be deflected in another direction.
- (4) A secondary earthen backstop consisting of an earthen berm, material hill or excavated face shall be provided. The secondary backstop should be at least 30 feet wide and 16 feet high.
- (5) Operation of an archery range shall be allowed between the hours of sunrise and sunset.

Unlawful operation of an air gun, air rifle, bow and arrow, slingshot or BB gun is a class C violation.

Section 3. REPEAL. Sections 70-1 and 70-2 of Chapter 70, Offenses, of the Code of Ordinances of the City of Leavenworth, Kansas, in existence as of and prior to the adoption of this ordinance, are hereby repealed.

Section 4. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.

- G.(g) It is unlawful for any person who is a retail dealer to fail to post and maintain in a conspicuous place in the dealer's establishment the following notice: "BY LAW, CIGARETTES AND TOBACCO PRODUCTS MAY BE SOLD ONLY TO PERSONS 21 YEARS OF AGE AND OLDER." Retailer shall mean any person, firm or corporation engaged in the business of selling tobacco products, alternative nicotine products, or vapor products by personal handling to an ultimate customer or consumer.

H.Violation of this section is a class B violation punishable by a minimum fine of \$200.

6.8 LITTERING PROHIBITED.

- A. Definitions. As used in this Section, the term Litter shall mean any rubbish, refuse, waste material, garbage, trash or debris of any kind of description, including but not limited to improperly discarded paper, metal, plastic or glass regardless of size or value.
- B. General Littering Prohibition. No person shall intentionally or recklessly dump, throw, place, deposit or cause to be dumped, thrown, placed, deposited or left Litter into, upon or about: 1. Any public street, highway, alley, road, right of way, park or other public place, or any lake, stream, watercourse or other body of water except by direction of a public officer or employee authorized by law to direct or permit such act; or 2. Any private property without the consent of the owner or occupant of such property. Unsolicited forms of written communication otherwise protected by the First Amendment shall be deemed as Litter upon written or oral notice from the private property owner or occupant that consent to receive such communication is withdrawn.
- C. Littering from Motor Vehicle. No person shall throw, place or drop litter or allow Litter to be thrown, placed or dropped from a motor vehicle onto or upon any highway, road or street. The driver of the vehicle may be cited for any such refuse, object or substance thrown, placed or dropped from the motor vehicle, unless any other person in the motor vehicle admits to or is identified as having committed the act.
- D. Penalty. A violation of this section shall be a Class C violation punishable by a fine not to exceed \$500.00.

10.23 TRAFFICKING IN COUNTERFEIT DRUGS.

Trafficking in counterfeit drugs is intentionally manufacturing, distributing, dispensing, selling or delivering for consumption purposes, or holding or offering for sale, any counterfeit drug.

Trafficking in counterfeit drugs which have a retail value of less than \$500 is a Class A violation. (K.S.A. Supp. 65-4167)

9.9.2 DRUG PARAPHERNALIA, SIMULATED DRUGS AND CONTROLLED SUBSTANCES; DISPLAY, SALE, POSSESSION OR DELIVERY PROHIBITED.

- A.(a) No person shall sell or offer for sale, use or possess with intent to use:
 - (1) 1)Any simulated controlled substance as designated in K.S.A. 21-5701;
 - (2) 2)Any drug paraphernalia-, as designated in K.S.A. 21-5701, to use, store, contain, conceal, inject, ingest, inhale or otherwise introduce into the human body a controlled substance in violation of the Uniform Controlled Substances Act-, K.S.A. 65-4101 et seq., and any amendments thereto; or
 - 3)(3) Any drug paraphernalia to plant, propagate, cultivate, grow or harvest less than five marijuana plants.
- A.(b) The fact that an item has not yet been used or did not contain a controlled substance at the time of the seizure is not a defense to a charge that the item was possessed with the intention for use as drug paraphernalia.
- **B**-(C) No person shall deliver, possess with intent to deliver, manufacture with intent to deliver or cause to be delivered within this City any drug paraphernalia, knowing, or under circumstances where one reasonably should know, that it will be used to use, store, contain, conceal, inject, ingest, inhale or otherwise introduce into the human body a controlled substance in violation of the Uniform Controlled Substances Act and amendments thereto.
- G-(d) It shall be unlawful for any person to display for sale any drug paraphernalia or simulated controlled substance or simulated drug in or upon any premises.
 - Nothing in this Section shall be construed to prohibit the selling, dispensing, or giving away of such items by a practitioner or pharmacist to a patient for lawful purposes.
- 2)(e) For the purpose of sentencing the offense is classified as a Class A misdemeanor as set forth in the Uniform Public Offense Code and the

sentence shall be a definite term of confinement in the city or county jail which shall be fixed by the Court and shall not exceed one year. In addition to or instead of the confinement authorized by law a fine up to \$2,500.00 may be imposed by the Court.

- (5) Operation of an archery range shall be allowed between the hours of sunrise and sunset.

Unlawful operation of an air gun, air rifle, bow and arrow, slingshot or BB gun is a class C violation.

Section 3. REPEAL. Sections 70-1 and 70-2 of Chapter 70, Offenses, of the Code of Ordinances of the City of Leavenworth, Kansas, in existence as of and prior to the adoption of this ordinance, are hereby repealed.

Section 4. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.

AN ORDINANCE AMENDING CHAPTER 110 SECTIONS 110-1 – 110-2.1 OF THE CODE OF ORDINANCES REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF LEAVENWORTH, KANSAS; INCORPORATING BY REFERENCE THE *STANDARD TRAFFIC ORDINANCE* FOR KANSAS CITIES, EDITION OF 2018, WITH CERTAIN OMISSIONS, CHANGES, AND ADDITIONS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEAVENWORTH, KANSAS:

Section 1. That the Code of Ordinances, City of Leavenworth, Kansas, Chapter 110, Traffic and Vehicles, Article I; In General, Section 110-1 through Section 110-2.1 shall be amended to read as follows:

Sec. 110-1 Standard Traffic Ordinance for Kansas Cities – Adopted.

There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Leavenworth Kansas that certain standard traffic ordinance known as the *Standard Traffic Ordinance* for Kansas Cities, Edition of 2018, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified, or changed.

Sec. 110-2 Same-Marked copies on file.

One copy of said *Standard Traffic Ordinance* shall be marked or stamped "Official Copy as Adopted by Ordinance No. 8085" with all sections and portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable business hours. The police department, municipal judge, and all administrative departments of the city charged with enforcement of the ordinance shall be supplied at the cost of the city, such number of official copies as such *Standard Traffic Ordinance* similarly marked, as may be deemed expedient.

Sec. 110.2.1 Same-Amendments.

Article 1. Definitions.

Section 1. Definitions be amended by adding the following definition: *Gasoline or Electric Powered Scooters* means any motorized scooter not more than 51" in length, 14" in width and 30" in height, by the manufacturer's specifications and having a seat designed to be straddled by the operator."

- Article 4. Traffic Signs, Signals and Markings be amended by adding the following: Section 21a. Gasoline or Electric Powered Scooters. "It is unlawful to operate, or for the owner to permit the operation of, a gasoline or electric powered motorized scooter upon a street, highway, public parking lot, or public parks area."
- Article 14. Miscellaneous Rules, Section 114.5 be amended, adding, as follows:(c) "Unlawful operation of worksite utility vehicle except for public safety and city maintenance staff."

Section 2. That all ordinances found to be in conflict with the said "Standard Traffic Ordinance for Kansas Cities, Edition of 2018" be and the same are hereby repealed.

Section 3. That this ordinance shall take effect and be in force from and after its passage, approval, and publication as provided by law.

ISSUE: Review and approve the recommendation for employee benefit coverages to be effective December 1, 2018.

STAFF RECOMMENDATION: Staff recommends renewal with the current providers for medical and dental coverage but is recommending a change in vision coverage provider for the new plan year beginning December 1, 2018. Current providers are: United HealthCare for medical coverage, Delta Dental for dental coverage and VSP for vision coverage.

BACKGROUND: The City has maintained employee medical coverage through United HealthCare since December 1, 2005. UHC continues to demonstrate their ability to provide a long-term strategic partnership in health care with the City. The renewal bid from UHC, with no plan design changes, came in at a 7.33% premium increase. This renewal reflected well below what was calculated/required based on our experience rating and also about 3.5% below the market trend. Based on the renewal quote coming in under budget and the intent to maintain a long-term relationship with one provider, a market search was not conducted for medical coverage.

The City renewed with Delta last year with no premium increase and a 5% rate cap guarantee for 2019. The renewal from Delta for 2019 came in at a 5% premium increase with no plan design changes. We have one year remaining with the 5% rate cap guarantee from Delta Dental.

VSP provided a renewal quote of a 3% increase with no plan design changes. This has been an area of discussion for several years as the plan benefits are not very extensive. We currently have our plan design to cover one eye exam per year with a \$10 copay and frames/lenses/contacts covered once every two years, up to \$120 allowance, with a \$25 copay. Since we were at the end of our 2-year contract with VSP, we decided to put the vision service out for bid to see what other carriers were available with a slightly enhanced plan design.

Five providers, including VSP, responded to the bid and 4 of the 5 provided a quote, with one company (Principal) declining to bid due to not being competitive. The plan design received from all carriers included the once a year eye exam with a \$10 copay but enhanced the frames/lenses/contacts benefit to once a year up to \$130 allowance with a \$25 copay. VSP came in with the highest quote for this plan design with a 56% increase; while UHC came in with the lowest quote for this plan design with an 8% decrease from current rates.

In addition, UHC also offers a 0.5% decrease on our medical premium for having a second line of coverage with them. This reduces the medical renewal from 7.33% to 6.83%; creating greater cost savings for both the employees and the City.

The Employee Council met to discuss the renewal of medical, dental and vision coverage. The results of the market bid for vision coverage was reviewed and taken back to their respective groups for feedback/questions. The overwhelming response from all divisions/department was favorable to change carriers for vision coverage from VSP to UHC with the enhanced benefits and take advantage of the lower cost for both vision as well as medical.

Based on the above information, Staff is recommending the City renew with UHC for medical and with Delta Dental for dental coverages, with no plan design changes to either of those coverages. However, it is being recommended to terminate the contract with VSP for vision coverage and accept the proposal from UHC for vision coverage with the enhanced vision benefits identified above.

If the Commission approves the Staff recommendations, the renewal date for the medical, dental and vision plans would be December 1, 2018. The change of carriers for vision coverage would require mandatory open enrollment sessions and all employees would have to attend one of the sessions. Open enrollment informational meetings for employees and retirees will be scheduled for the weeks of October 8th and 15th. As in the past, our benefit providers would be available during these informational meetings to answer any questions and/or provide additional information. Employee enrollment for medical and/or dental coverage would only be required for those employees interested in electing new coverage, changing plan levels or adding/dropping dependents from coverage.

BUDGET IMPACT: UHC is providing a 7.33% increase, which would be reduced to a 6.83% increase with the addition of vision coverage through UHC; Delta Dental is providing a 5% increase; and UHC Vision provides an 8% decrease from the current premiums. All of the renewals for coverage come in well under the 2019 budgeted amount of 8%.

ISSUE:

Review bids received for Building Automation System Replacement and Upgrades at Fire Station #1.

BACKGROUND:

Due to the unreliability of the existing HVAC system at Fire Station #1, staff contacted a large respected commercial HVAC contractor to assess the existing system and identify the source of repetitive failures. Their findings primarily pointed to conflicts within the control system; and they proposed a complete re-commissioning of the existing system. While performing the re-commissioning work, the contractor found multiple issues that could not be corrected. They determined that the existing system is no longer capable of performing as it was designed to do. The contractor recommended that we replace the automation system.

Staff contacted an engineering firm (recommended by a representative from the Leavenworth School District) to perform their own analysis of the existing system. They also determined the system has many failures and replacement would be the best option. During budgetary discussions in the fall of 2017, it was decided to move forward with the control system replacement.

Staff contacted the same engineering firm to develop a scope of work and bid package for sending to contractors that specialize in control systems, and to publish at local media sites. A non-mandatory pre-bid meeting was scheduled for Monday, July 9, 2018 at 2 pm to allow prospective bidder's access to Fire Station #1 and ask any questions they may have. Bids were opened on Thursday, August 23, 2018 at 2 pm.

DISCUSSION:

As part of the 2018 City Commission Goals, staff was directed to investigate the potential for some form of rental inspection program.

Housing stock within the City of Leavenworth is comprised of over 50% rental units, and staff is frequently contacted by tenants with reports of substandard conditions in such units. In 2009, the City adopted a Rental Registration ordinance, requiring a one-time registration by property owners of each rented unit. This ordinance does not address any type of inspection or minimum standards for living units. Exterior inspection of all residential units, both rental and owner-occupied, is handled through standard Code Enforcement activity.

A number of other cities in Kansas have enacted a rental inspection program of some form to address concerns with living conditions and life-safety issues in residential rental units. In 2016, the State of Kansas enacted a statute prohibiting the periodic interior inspection of residential property. However, the statute specifically allows a lawful occupant to request an interior inspection by the City. The passage of this statute affected the structure of many of the rental inspection programs in place at the time that had required periodic interior inspections of residential rental units.

The following cities in Kansas are known to have existing rental inspection programs; Kansas City, Overland Park, Lawrence, Coffeyville, Mission, Fairway, Leawood, Lenexa, Merriam, Prairie Village, Roeland Park, Westwood, and Hutchinson. For the purposes of comparison, staff examined a number of key components in each program.

For the purposes of discussion, two cities' programs; Merriam and Hutchinson, are presented as example. The rental inspection program in the City of Merriam has been in place for over a decade and has proven very successful both in terms of level of compliance from property owners, and in reducing the number of code violations and complaints received on rental properties. The City of Hutchinson enacted their rental inspection program in 2016. They employed a proactive approach to implementing the program and within the first two years have 95% compliance in terms of property owners registering their properties. At approximately 5,500 rental units within the City, Hutchinson has found their program to be self-funding and able to support the cost of one full time rental inspector. Both cities use a relatively streamlined process for registration and assessment of fees, simplifying the program as much as possible for both property owners and tenants.

Other programs examined contained complex registration, inspection and fee assessment structures, or were simplified to the point of having little effect.

One commonality between the programs examined as a key indicator to success is the requirement for an annual rental license to be obtained for each residential rental unit. This creates accountability for property owners, and allows staff to manage and track rental units within the city. Absence of the requirement for an annual rental license would take away the ability of staff to monitor rental stock and negate any benefits of such program.

Positive effects of rental inspection programs can include:

- Increased accountability for property owners
- Decrease in code violations
- Central point of contact for property owners and tenants
- Better oversight of life-safety issues in rental units

Potential cons may include:

- Program may not be 100% self-funding
- Increased burden on staff time
- Difficulty identifying all rental units and gaining compliance

Sec. 2-351. - Rental registration.

The provisions of this article shall apply to all rental dwellings, including rented single-family and multifamily dwellings and rented dwelling units in owner-occupied dwellings.

- (1) A one-time registration shall be filed per owner of all property in which rental dwellings exist providing all property is titled under the same name; and
- (2) If the owner of the property in which rental dwellings exist is titled under different names, each property titled differently will be required to submit additional registrations; and
- (3) The city shall have the authority to exercise its powers under this article, including the power to enforce or to declare one or more of owner's rental dwellings in violation of this article.

The provisions of this article shall not apply to hotels, motels, and bed and breakfast facilities licensed by the State of Kansas, convents, monasteries, parish houses or rectories, mosques, temples, churches, synagogues, hospitals, licensed nursing homes or assisted living facilities subject to inspection by other government agencies, jails, and residential dwelling units owned and operated by any housing authority. (Ord. No. 7785, § 1, 11-25-08)

Sec. 2-352. - Registration.

The owner of each rental dwelling shall make written application of registration to the city clerk's office all residential dwellings beginning April 1, 2009. The owner of each rental dwelling shall have six months for compliance. In addition, other than during the initial implementation of this article, the owner of any rental dwelling constructed or converted to rental usage shall make written application to the city for registration as herein provided prior to initial occupancy. No application shall be considered without payment of a \$20.00 fee. If the owner of each rental dwelling fails to register the rental property by October 1, 2009 the registration fee will be \$40.00. Such application shall be made on a form furnished by the city for such purpose and shall set forth the following information:

(1) Owner's name, street and mailing address, and telephone number. If the owner is a partnership or limited liability company, the name of the entity and the name, residence address, and telephone number of the managing partner or member shall be provided. If the owner is a corporation, the name and address of the corporation and the name, residence address, and telephone number of the chief operating officer shall be provided. Further, a post office box is not acceptable for any such address as required in this section. A street address must be provided for any such person. In cases where the owner of a rental dwelling resides more than 40 miles outside of the City of Leavenworth, Kansas, the owner shall designate a resident agent who shall reside

within a 40-mile radius of the corporate limits of the City of Leavenworth, Kansas. That registered agent's name, street and mailing address, and telephone number must be included on the application. The registered agent shall be jointly and severally responsible with the owner for:

- a. The upkeep and maintenance of the premises;
- b. Compliance with this article and all other codes regulating the premises; and
- c. Acceptance of service of process and of all notices under this article.
- (2) Manager's name, street and mailing address, and telephone number. If some person other than the owner, manager or agent is actively involved in and responsible for the maintenance and management of the premises, that person's name, street and mailing address, and telephone number must be given in the application.
- (3) Address identifying location(s) of the rental dwelling owned by the owner.
- (4) Number and type of rental units in building (dwelling units, rooming units or shared bath units).
- (5) The name, address, street and mailing address, and telephone number of the person designated as responsible for maintaining a current register of all tenants and other persons with a lawful right of occupancy to a rental dwelling.

Sec. 2-353. - Duties of licensee.

Every owner of a residential rental property shall notify the city in writing of any changes of information contained in the last registration filed within 30 days of the changed information.

Sec. 2-354. - Registration requirement; penalty.

- (a) Owners must declare all properties owned that are rented or intended to be rented.
- (b) No person shall allow any dwelling units in the city to be occupied or rent to another for occupancy unless the owner has first registered under the terms of this article. This applies to people who allow to be occupied or rent to another for occupancy at the time this article is implemented.
- (c) Failure to comply with any term of this article shall be unlawful. The minimum penalty for a registration violation will be \$150.00. Each day that a person fails to comply as required by this ordinance shall constitute a separate offense. Fines and penalties shall be consistent with the City of Leavenworth "Uniform Offense Code."

Sec. 2-355. - Remedies in this article are not exclusive.

The remedies provided in this article are not exclusive. They are in addition to and do not supersede or pre-empt other remedies such as a declaration of being unsafe or dangerous, written violation orders and warnings and criminal charges for violation of substantive provisions of any city or state code relating to housing maintenance, fire safety, building codes, zoning, health and the like. Further, the remedies in this article do not supersede or affect the legal rights and remedies of tenants provided under state law or this Code.

Sec. 2-356. - Definitions.

When used in this chapter, the following words and terms shall have the meanings ascribed to them in this article:

Dwelling: A building or structure or portion of a building or structure designed for or used for human habitation, including any rental unit or rooming unit.

Dwelling unit or *unit:* Any room or group of rooms located within a dwelling and forming a single habitable unit with cooking, living, sanitary and sleeping facilities or rooming unit.

Operator/manager: Any person who, alone or jointly or severally with others, shows rental dwelling units to prospective tenants and/or enters lease agreements on the owner's behalf and/or receives rent from tenants.

Tenant/occupant: Any person living, sleeping, cooking or eating at or actually having possession of a rental dwelling, dwelling unit or a rooming unit.

Owner: Any person who, alone or jointly or severally with others:

- (1) Has legal title to any building with or without accompanying actual possession thereof; or
- (2) Has charge, care or control of any building or structure or part thereof as agent or personal representative of the person having legal title to the building or structure or part thereof; or
- (3) Has possession or right to possession under a contract for deed.

Person: Any individual, firm, corporation, association, partnership, cooperative or governmental agency.

Premises: The building in which the unit is located and all land appurtenant to such building.

Registered agent: The person designated by the owner to be the agent required by <u>section 2-352</u> of this article.

Rental housing complex: Any residential rental units of any nature or character on one property or on adjacent property under common ownership.

Unit: Any dwelling unit or rooming unit.

Sec. 2-357. - Interpretation.

- (a) *Liberal construction.* The provisions of this article shall be liberally construed to effectively carry out its purposes which are hereby found and declared to be in furtherance of the public health, safety, welfare, and convenience.
- (b) Invalidity. If for any reason any chapter, article, section, subsection, sentence, portion or part of the proposed ordinance [this article] set out, or the application thereof to any person or circumstance is declared to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portions of the Code or other ordinances.

Secs. 2-358-2-399. - Reserved.

12-16,138. Cities; counties; prohibiting periodic interior inspections of residential property; exceptions. (a) No city or county shall adopt, enforce or maintain a residential property licensing ordinance or resolution which includes a requirement for periodic interior inspections of privately owned residential property for city or county code violations unless the lawful occupant has consented to such interior inspections. This subsection shall not apply to inspections of mixed-use residential and commercial property. This subsection shall not prohibit a city or county from conducting plan reviews, periodic construction inspections or final occupancy inspections as required by building permits.

(b) Any lawful occupant residing in privately owned residential housing located within the corporate limits of a city may request an inspection at any time by the city or, if the property is located in the unincorporated area of the county, by the county to determine code violations.
