## Call to Order:

Chairman Charles Davis called the meeting to order at 4:15 p.m. and a quorum was present.

## Approval of the September 12, 2022 minutes:

Board Member Brian Keeley called a motion of the minutes, as presented.

Seconded by Board Member Sr. Paula Rose.

Approved by a vote of 5-0

#### **Open Public Hearing:**

Public Hearing for 2023-24 unmet needs for low/moderate income citizens and input for 2023-24 Annual Action Plan.

Chairman Charles Davis called to open the Public Hearing Board Member Brian Keeley motioned to open the public hearing Seconded by Board Member Ralph Taylor Passed by a vote of 5-0

#### Public Comment:

Mr. Michael Trapp, Executive Director of Alliance Against Family Violence

- expressed a need for handicap accessibility funding or physical improvements for nonprofit organizations
- expressed opinion that nonprofits are not considered to be economic development by the City

#### Close Public Hearing:

No additional public comment Board Member Tony Majors motioned to close the public hearing Seconded by Board Member Brian Keeley Approved by a vote of 5-0

## Discussion of Scoring Sheets & Aggregate:

Mrs. McKeel reviewed current status of the public service agencies and how their funds are trending for the current grant year. There are no issues and funds are trending well with expectation to be expended on time.

Mrs. McKeel discussed the blank CDBG application provided to Board Members to reference as they score each agency utilizing the aggregate sheets. McKeel provided her personal cell number on their copies so the Board Members can reach out to her any time due to everyone having full time jobs during the day.

Total of 6 agencies that submitted an application and the Board Members were provided with a score sheet for each agency. McKeel reviewed the point system of Needs, Project, Budget/Timeliness, and Performance Measures to assure everyone is scoring with fluent concept. McKeel requested score sheets be completed by March 1<sup>st</sup>, 2023.

Chairman Charles Davis asked if these score sheets can be reconfigured. McKeel replied with not wanting to change anything up on them this year, yet encouraged if there is anything they wanted to add or omit to please make notes for changes to be made for next year. Aggregate data of the scoring sheets will be provided at the next meeting before voting.

Vice Chairman Ralph Taylor questioned remaining funds from St. Vincent. Mrs. McKeel stated that by the end of the fiscal year in June of 2023, all agencies will not have any funds remaining. The applications they will be scoring for the next program year beginning, July 1, 2023. Reimbursement request provisions in the contracts were explained.

Mrs. McKeel asked CDAB to keep in mind this is a competitive grant and to jot down questions for the next meeting when they have an opportunity to have those answered by the public service agencies.

Mrs. McKeel stated that the current public service agencies receiving these funds have all applied again and now the addition of Alliance Against Family Violence, as they had been closed for a duration and have not received CDBG funds in the recent past. Chairman Charles Davis welcomed them back.

#### Discussion of possible changes to Home Repair Program:

Mrs. McKeel gave an update to the current, 2022 program year, Home Ownership Program & Home Repair Program.

#### Home Ownership Program

- goal of 5 homes and it has already been met
  - 3 were Female Head of Household

#### Home Repair Program

- Goal of 11 households and has served 6
  - 3 new roof, 1 furnace-AC, 1 furnace-AC-water heater, 1 hole in roof with furnace-AC & ventilation piping
  - 5 were Female Head of Household
  - 4 were over age of 65

Mrs. McKeel stated that currently the Home Repair awards up to \$8,000.00 for moderate income household & up to \$10,000.00 for low income. Discussed materials and labor cost continue to rise. Requested Board Members to bring questions if they need further data to consider voting to raise the award amount up to \$15,000.00.

Vice Chairman Ralph Taylor asked how citizens are notified of the Home Repair Program. Mrs. McKeel advised from social media, First City Connection, Channel 2, emails, and phone calls. The Public Information Officer helps advertise every quarter. More often the citizen references the First City Connection or they heard from a friend.

Board Member Brain Keeley asked where the additional funding would come from. Mrs. McKeel advised there is no additional funding. The award amount can be raised and goal of homes lowered to meet the need. A substantial amendment may be needed.

# Other Matters:

The 2023 Annual Action Plan will be posted by March 10<sup>th</sup> on the City's website, Leavenworth Public Library, and at the Community Development Office.
