

# Riverfront Park Campground







**Physical Address: 1201 Riverfront Park Road**

**Campground is open April 1 through October 31. Park hours are 7 a.m. to 10 p.m.**

## Reservations

 April-October – Contact the Riverfront Campground Manager at (913) 290-0034

## Fees – due at time of check-in for length of stay

-  Camper Pad with restroom key and electricity (30 amps) - \$15/day
-  Pet Fee - \$2/day/pet
-  Dump Station for non-campers - \$10
-  Key Deposit - \$20 refundable deposit, refunded when keys are returned at check-out

## Limitations

- ⊗ Trailers over 32' long may not make it across the train tracks.
- ⊗ Shower house is for paid campers only, not for public use.
- ⊗ Maximum of one vehicle per site.
- ⊗ There are no sewer hook-ups, only a dump station.
- ⊗ Electrical outlets are 30 amps only.
- ⊗ Two water outlets available. Bring a hose and splitter to hook up to water.



## Camping Regulations

1. Fees must be paid to the Manager prior to the selection of a camping spot.
2. Permits must be clearly displayed on campsite post.
3. All vehicles must be parked on one of the designated camping pads.
4. Campers may reserve a camping pad in advance by contacting the campground manager at 913-290-0034.
5. Campers may stay in the park a maximum of 7 days. Long-term arrangements may be made at the manager's discretion.
6. **Check in time is 4 p.m. Check out time is 11 a.m. daily.** Campers remaining beyond this time will be charged another day's camping fee.
7. Please keep the campground gate closed and locked at all times.

## Park Rules

1. Speed limit - 10 MPH
2. Park closes at 10 p.m. Non-campers must leave the park at this time.
3. **Quiet hours** are from 10 p.m. through 7 a.m. Noise that can be heard outside your campsite is prohibited. No generators, loud radios, or shouting.
4. There is a limit of one vehicle per camp site. Extra vehicles may be parked in the boat ramp area. All vehicles must remain on designated roadways or in parking areas.
5. **Alcoholic beverages are not allowed in City Parks.**
6. Pets must be kept on a leash at all times and owners must clean up after their pets. Pets should never be left unattended and must be inside during quiet hours.
7. Please help keep the park clean by using the conveniently-located trash containers.
8. Non-campers must park outside the campground gate.
9. Parties or disturbances will not be tolerated. In the event of a disturbance, all parties will be asked to leave the park, including the camper, with no refund of fees.
